PRIVACY POLICY

The Widemouth Manor is committed to protecting your privacy, and complies with the principles of the relevant data protection regulations. (General Data Protection Regulations which comes into effect on the 25th May 2018)

This privacy policy explains how and why we collect your personal data and how it will be used.

PERSONAL DATA WE COLLECT

- When hotel room bookings are made either online (via the internet), or personally on the telephone, you will be asked to provide certain information, including your name, contact details, and debit or credit card information.
 - We may also collect information about your usage of our website.
- In the future we may, for the purpose of email marketing, collect names and email address of those that wish to receive our emails. This information will be collected via a sign-up form on our website, from online booking sites (through third parties) and via our telephones.

HOW WE USE PERSONAL DATA

- Your personal data/information will enable us to supply the services you have requested, and to bill you for these services. Your information may also be used to contact you concerning your booking should we need to do this.
- Your email address may be used to keep you informed about relevant news offers or events we may be holding at the Widemouth Manor. You can unsubscribe to these emails at any time.
- For those that have consented to email marketing, we use names and email addresses so that we can keep people informed about relevant news and offers/events. We may also use physical address data to ensure the emails are as relevant as possible.
- These emails will only ever be sent to people that have chosen to receive them, and we always make sure the content is interesting and relevant to your request.

WHO WE SHARE PERSONAL DATA WITH AND WHY

- Some of the information provided to us may be accessed by third parties, some of whom may be located outside the European Economic Area. These

third parties act for us for the purposes outlined in this policy, processing information, processing credit card payments, and providing support services on our behalf.

- Unless required or permitted to do so by law, we will not otherwise share, sell or distribute any of the information you provide to us without your consent.
